IT: Updates – Johnathan Brownlee

- Wireless voice or data device changes or requests are now available as an online service request
 - Open a ticket to request an IT Service by going to MyPima > @Work > IT Service Request _ Submit a Ticket > Telephone Services. Then, select either Cellular Device Request for a new phone, Wireless Data Device request, or a Cellular Device Change Request for any issue involving an existing college issued service or device. Both wireless phones and internet devices are covered by this ticket type.
 - o This service request is used to request a device to be issued, make a change to services, cancel a line, or request a transfer of services already issued.

- Phase three of testing for Google Drive File Stream is complete. This new utility allows a desktop or laptop to mount a Google Drive folder like a network file directory.
 - o Shared departmental Google Drives are also coming for shared file areas using Google Drive upon department leadership request.
 - o The use of a shared department Google Drive first requires a departmental file plan to be put in place with assistance from the Records Management Department. The file plan helps us to track what sort of records and files might be stored in the shared drive so we can protect and assist in retention of those materials.
 - o Google Drive experiences will vary with the type of network service used to access G-suite services, e.g. your local Internet service. It is not, however, dependent on how busy the College's internal network might be at the time the files are being accessed.

Environmental Health & Safety: Updates - Ouatfa Chuffe-Moscoso

- 6.000 COVID tests administered at PCC sites.
- North West campus is now a testing site.
- Pima County Vaccination Update
 - Vaccination efforts continue for priority groups under Phase 1A (health care professionals and support workers, and staff and residents in skilled nursing homes and assisted living facilities).
 Vaccinations for Phase 1B.1 a-d priority groups began Jan. 15.
 - o Through February 1, 2021: 165,950 doses allocated to the County; 136,100 doses arrived.
 - o 119,585 vaccinations completed through Monday February 1, 2021.

- o The State allotted 29,850 doses to the County for the week beginning Feb. 1, with delivery expected by Feb. 3 at the latest. Pima County released information on Myths vs Facts for COVID-19 Vaccine. Pima County recommends continuing to follow the steps to Protect Yourself and Others by masking, distancing and hand washing. The State Retail Pharmacy Program allocated a limited amount of vaccine directly to six pharmacies in Pima County (updated 01/28/2021).
- Approximately 674,000 people are eligible for vaccination in Phase 1B in Pima County.
- O Cases have been declining in the last 3 weeks in AZ.
