- Fall Planning: Dolores Duran-Cerda, Executive VC and Provost; David Dore, President of Campuses and Executive Vice Chancellor and Lamata Mitchell, Vice President of Instruction
 - Pima All Invitation coming to discuss Fall Plans with the Chancellor on March 12.
 - Dr. Garcia Pima County Board Officer will be in attendance to discuss the overview. Dr.
 Garcia is optimistic that by summer 75% of residents in Pima County will be vaccinated.
 - Last BOG three scenarios presented
 - Plan A Full operation of post Covid new normal
 - Plan B Open 50% of courses at any given time, which at the time was the most likely scenario

- Plan C Virtual online and a handful of hybrid courses.
- After the new information from Pima County, national trends, K-12, and University of Arizona's plans to move forward, Plan A is now the most likely scenario.
- Protocols in place now including masks and 6 feet social distancing. With Plan A, the change would involve removing the 6 feet social distancing component.
 - Strict cleaning protocols will be enforced. Including some hytech systems for cleaning using Chrissa funds. Mask will still be required per CDC Guidelines. Vaccinations are optional so masks will be required with allowances for meals and other scenarios.
 - In terms of service, you may see various work models including work from home mixed with some face-to face. This will be rolled out by ea. dept.
